**ARTICLE I
NAME**

The name of this corporation is CLUB CHALET HOMEOWNERS COOPERATIVE ASSOCIATION, INC.

**ARTICLE II
NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is:

The purpose of this corporation is to engage in any lawful act or activity for which corporations may be organized under the general corporation law of the State of Florida. This shall include but not be limited to the following:

To conduct all business necessary of a corporation as a manufactured mobile home tenants' organization in the State of Florida, including but not limited to, the representation of its tenants and members, the purchase of the mobile home park, and to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, and with, goods, wares, merchandise, real and personal property and services, of every class, kind, and description. The corporation shall have the power to negotiate for, acquire and operate a mobile manufactured home park and in particular a mobile home park known as Club Chalet, Inc., in the County of Pinellas, State of Florida, on behalf of the residents. When once acquired, the corporation has the power to convert the mobile home park to a condominium, a cooperative, or other type of ownership. The corporation shall have such other powers as are granted in Chapters 719 and 607 of the Florida Statutes.

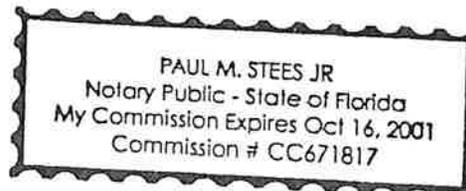

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, for profit, under the laws of the State of Florida.

ARTICLE I
